
# GOVERNOR NEWSOM'S MODEL ORDINANCE: ADDRESSING ENCAMPMENTS

Health, Housing, Homelessness, and Human Services Committee June 16, 2025



### **June 2024**

• The U.S. Supreme Court case ruled 6-3 that jurisdictions may enforce ordinances prohibiting homeless individuals from sleeping in public spaces using items like blankets or cardboard, even when no shelter is available. The Court found that such laws do not violate the Eighth Amendment's ban on cruel and unusual punishment.

## **July 2024**

• Governor Newsom ordered state agencies to clear homeless encampments on state land and encouraged local jurisdictions to adopt encampment policies that align with those of CalTrans through Executive Order N-1-24.

## May 2025

Governor Newsom released a "model ordinance for cities and counties to immediately address encampments with urgency and dignity". Additionally, Cal ICH updated their guidance on addressing encampments to align best practices with the Model Ordinance.

Service Connections	
Model Ordinance	" officials, or any agent acting on their behalf, shall make every reasonable effort to identify and offer shelter at an emergency shelter, navigation center, or other appropriate housing, and to offer supportive services, to persons living in the encampment."
Cal ICH Guidance on Encampments	" make every effort to identify and offer shelter to persons living in an encampment in advance of taking action to remove an encampment. If shelter cannot be secured prior to removal despite these efforts, it's recommended that a local government ensure that there are reasonably accessible locations within the jurisdiction where a person may lawfully sleep"

### County Encampment Resolution Policy

- 1. Toxic sharps: needles, scissors, knives.
- 2. Chemicals: bleach, paint, oils, etc.
- 3. Items (including bedding and clothing) soiled by infectious materials: human waste, bodily fluids.
- 4. Moldy, mildewed items.
- 5. Items that may be infested by rodents and insects: rats, mice, fleas, lice, bed bugs.
- 6. Items that pose a risk of fire or explosion, combustibles, and propane tanks; any item containing fuel or corrosives or other unidentified liquids.
- 7. If personal belongings are co-mingled or littered with needles, human waste, or other health risks, employees/contractor may dispose of the entire pile of belongings and are not required to sort through and attempt to remove the health or safety risks. The presence of clothing in a backpack or container shall not be the sole reason to discard the backpack or container.
- 8. Mattresses, box springs, furniture with fabric, padding, or is porous; sheds, fixed or rolling structures; and bulky items. Sheds, structures, or rolling structures may be demolished if not removed by individuals experiencing homelessness prior to the encampment removal.
- 9. A "bulky item" is any single item that is over 50 pounds and requires more than two persons to safely lift.
- 10. Perishable items, perishable food.
- 11. Controlled substances, drugs with or without prescription and medications of any kind.
- 12. Contraband, weapons, and illegal items.
- 13. Trash, garbage, and/or debris. This includes property that appears to have been discarded by its owner, including broken appliances or broken furniture.
- 14. Motor vehicles

#### Model Ordinance

Items that constitute a health and safety risk and will not be collected include, but are not limited to:

- (1) Toxic sharps: needles, scissors, knives.
- (2) Chemicals: bleach, paint, oils, etc.
- (3) Items (including bedding and clothing) soiled by infectious materials, including human waste and bodily fluids.
- (4) Moldy, mildewed items.
- (5) Items that may be infested by rodents and insects: rats, mice, fleas, lice, bed bugs.
- (6) Items that pose a risk of fire or explosion, combustibles and propane tanks; any item containing fuel or corrosives or other unidentified liquids.
- (7) Backpacks and closed containers that have been determined by an individual licensed to identify and handle hazardous materials to contain items listed in (1)-(6) above or
- (iii) below. Such backpacks and closed containers may be discarded where no individual licensed in hazardous materials is present to make a determination.
- (8) If personal belongings are co-mingled or littered with needles, human waste, or other health risks, the entire pile of belongings may be disposed of. The presence of clothing in a backpack or container shall not be the sole reason to discard the backpack or container.
- (iii) Bulky items such as mattresses and sheds, perishable items such as food, controlled substances, contraband, and trash or debris will not be collected and stored. Contraband and controlled substances should be handled by trained professionals and consistent with applicable law

- Existing County ordinance combined with the adopted Encampment Resolution Policy generally meet all components of the Governor's Model Ordinance except for certain banning elements, particularly surrounding structures, camping, and sleeping in public.
- The County offers a more human-centered approach through:
  - additional 24 hours of notice that does not include weekends and holidays to ensure individuals are not displaced when access to resources are limited
  - additional 30 days of storage
  - different levels of interventions
