**01. DECLARATION:**

The Monterey County Workforce Development Board, hereinafter called "MCWDB", and Rancho Cielo, Inc., hereinafter called "PROVIDER" wish to amend their Memorandum of Understanding (MOU), effective September 1, 2016, to extend the term, to reflect changes in the costs of services, and to revise the amount of project funds awarded to PROVIDER, reflecting a decrease in participants it serves in the AB 2060 Supervised Population Workforce Training Grant Program 2.0. The parties further wish to provide for administrative costs for supervising the grant incurred by the MCWDB and to implement budget changes subsequently required by the State of California.
