Resolution honoring **Hon. Eduardo M. Ochoa** as the **2019 Monterey Peninsula Chamber of Commerce Ruth Vreeland Memorial Public Official of the Year**.

WHEREAS, since 1994, the Monterey Peninsula Chamber of Commerce has awarded distinguished civic leaders—whose qualifications include serving as an elected official or as an official in the public sector, having had a significant positive economic impact on the business community, and having demonstrated community leadership to the citizens of the Monterey Peninsula—with the *Ruth Vreeland Memorial Public Official of the Year Award*; and

WHEREAS, **Hon. Eduardo M. Ochoa** has been president of Cal State University, Monterey Bay since 2012. He has worked for over 30 years as a faculty member and administrator at campuses in the Cal State system, including Fresno State, Cal State Los Angeles, Cal Poly Pomona and Sonoma State University.

WHEREAS, **Hon. Eduardo M. Ochoa** served as provost and vice-president for academic affairs from 2003-2010 at Sonoma State. From 2010-2012, he was Assistant Secretary for Postsecondary Education in the Obama Administration.

WHEREAS, **Hon. Eduardo M. Ochoa** serving as the chief advisor on higher-education matters to the Secretary of Education and heading the Office of Postsecondary Education, which administers most of the Departments of Education’s higher education programs.

WHEREAS, in, **Hon. Eduardo M. Ochoa** a native of Argentina, has a B.A. in physics and philosophy from Reed College, a M.S. in nuclear science and engineering from Columbia University, and a Ph.D. in economics from the New School for Social Research.

WHEREAS, **Hon. Eduardo M. Ochoa** and his wife, Holly Byers Ochoa, a historian, writer, and editor have two sons, Michael and Eric.
