WHEREAS, the District must meet current maintenance and operating expenses during the periods of time between property tax payment receipts; and

WHEREAS, the District does not have sufficient funds on hand to provide for the operation of the District during the Fiscal Year ending June 30, 2027; and

WHEREAS, Article XVI, Section 6, of the State Constitution authorizes the temporary transfer of funds in the custody of the County Treasurer upon the approval of the Board of Supervisors; and

WHEREAS, the District has anticipated property tax revenues of \$17,976,388 and total budgeted revenues of \$20,463,491 for Fiscal Year ending June 30, 2027; and

NOW, THEREFORE BE IT RESOLVED that the Monterey County Board of Supervisors hereby:

- a. Approves a request from the Monterey County Regional Fire District (“District”) for a dry period loan of \$8,000,000 for the Fiscal Year ending June 30, 2027

b. Approves and authorizes execution by the County Auditor-Controller of a Temporary Transfer of Funds Agreement with the District, setting forth the terms and conditions of repayment of the dry period loan in the amount of \$8,000,000 for the Fiscal Year ending June 30, 2027; and

c. Authorizes the County Auditor-Controller and County Treasurer-Tax Collector to implement the temporary transfer of funds to the District in the amount of \$8,000,000 for the Fiscal Year ending June 30, 2027.
