Please tell us about yourself and why you want serve

I want to serve on the Housing Advisory Committee to be a voice for young people in our highly visible and burdensome housing crisis. As a 24 year-old who just moved into his own place, I know firsthand the difficulties young people face when attempting to rent our their own housing especially given the high cost of housing in Monterey County. However, this is far from my first interaction with the housing crisis left by generation before me. When my parents and I immigrated to the United States, we lived anywhere we could find reasonably priced housing which oftentimes meant we would have to live in other people's garages. I've also had close relatives of mine that lost their homes during the 2008 recession, witnessing firsthand how poor regulations and policy led to a preventable outcome. I also have the distinction of being an out and proud member of the LGBTQ+ community, which I believe brings a distinct worldview and perspective to the housing discussion given the rise of anti-LGBTQ+ policies and legislation being pursued state-wide and nation-wide.
