WHEREAS, under the Joint Occupancy Agreement with the Judicial Council of California, the State of California Courts is responsible for a share of the increased utility costs estimated at \$92,638 for the Monterey, Salinas and King City Courthouses;

WHEREAS, the County's share is \$441,075 and General Fund Contingencies is being requested to finance the shortfall; and

WHEREAS, General Fund Contingencies balance is \$6,587,990 and would be reduced to \$6,146,915.
