

**AMENDMENT #1 TO AGREEMENT # A-12761
BY AND BETWEEN
COUNTY OF MONTEREY &
GEO REENTRY SERVICES, LLC**

THIS AMENDMENT is made to the Agreement for the provision of services to adult offenders participating in the Day Reporting Center by and between **GEO REENTRY SERVICES, LLC**, hereinafter “CONTRACTOR”, and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as “County” (collectively, “the Parties”).

WHEREAS, the County and CONTRACTOR first entered into the Agreement on July 7, 2015 by board action for the term July 1, 2015 through June 30, 2018, not to exceed \$958,125 annually, for a total of \$2,874,375; and

WHEREAS, the County exercised its option to extend the Agreement on June 7, 2017, to extend the term for two (2) additional years through June 30, 2020 and increased the Agreement’s amount by \$958,125 annually, which resulted in a total amount not to exceed \$4,790,625; and

WHEREAS, the County has released RFP 10760 for the Adult Day Reporting Center for Probation and is pending award results; and

WHEREAS, the County and CONTRACTOR wish to amend the Agreement to increase the Agreement’s amount by \$479,062 for a total not to exceed amount of \$5,269,687, and extend the term expiration date for six (6) additional months to December 31, 2020, to allow CONTRACTOR to continue to provide services identified in the Agreement.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the Agreement, effective July 1, 2020, as follows:

1. Section 3.1, “TERMS OF CONTRACT”, shall be amended by removing “This initial term shall commence with the signing of this AGREEMENT through and including June 30,2018, with the option to extend this AGREEMENT for two (2) additional one (1) year periods”, and replacing it with “This AGREEMENT shall commence upon the signing of the AGREEMENT through December 31, 2020.”
2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the Agreement.
3. This Amendment No. 1 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.
4. The recitals to this Amendment No. 1 are incorporated into the Agreement and this Amendment No.1.
