## AMENDMENT NO. 1 TO FUNDING AGREEMENT BETWEEN COUNTY OF MONTEREY AND PACIFIC GAS AND ELECTRIC COMPANY

**THIS AMENDMENT NO. 1** to the Funding Agreement between the County of Monterey, a political subdivision of the State of California (hereinafter, "County") and Pacific Gas and Electric Company (hereinafter, "PROJECT APPLICANT") is hereby entered into between the County and the PROJECT APPLICANT (collectively, the "Parties") and effective as of the last date opposite the respective signatures below.

WHEREAS, PROJECT APPLICANT has requested County to provide input in the form of Tree Risk Assessment(s) (hereinafter, "services"), on so-called "franchise trees" that PROJECT APPLICANT proposes to either preserve, trim, or remove on Public right-of-way or County property as part of the Gas Transmission Pipeline Safety Program (hereinafter, "Project"); and

WHEREAS, PROJECT APPLICANT entered into a Funding Agreement with County on January 25, 2016 (hereinafter "Agreement") to provide funding for the services of the Project through September 30, 2016 for an amount not to exceed \$31,920; and

WHEREAS, County engaged Michael L. Bench, Consulting Arborist (hereinafter, "Contractor") to complete the services for the Project; and

WHEREAS, due to unforeseen circumstances and documentation requirements for the Project, additional time is necessary to allow the Contractor to complete services for the Project; and

WHEREAS, the Parties wish to amend the Agreement to extend the term for four (4) additional months to January 31, 2017 with no associated dollar amount increase to continue to allow funding by the PROJECT APPLICANT to the County for costs incurred by the Contractor and County departments to continue to provide services identified in the Agreement and as amended by this Amendment No. 1.

**NOW, THEREFORE**, the Parties agree to amend the Agreement as follows:

1. Amend the second paragraph in Section a., "CONTRACTOR", under Paragraph 6, "Payments to CONTRACTOR and County", to read as follows:

Should this AGREEMENT be terminated prior to January 31, 2017, any unearned balance of the Base Budget deposited by PROJECT APPLICANT to fund the Standard Agreement's Base Budget amount shall be returned to PROJECT APPLICANT within sixty (60) days of receipt of notice of termination by County.

2. Amend Paragraph 7, "Term", to read as follows:

AGREEMENT shall become effective January 13, 2016 and continue through January 31, 2017, unless terminated pursuant to Paragraph 8 or amended pursuant to Paragraph 12 of AGREEMENT.

3. Amend the first sentence of Paragraph 8, "Termination", to read as follows:

AGREEMENT shall terminate on January 31, 2017, but may be terminated earlier by-PROJECT APPLICANT or County, by giving thirty (30) days' written notice to the other.

4. Amend Section, "TO COUNTY", of Paragraph 21, "Notices", to read as follows:

- 5. All other terms and conditions of the Agreement remain unchanged and in full force.
- 6. This Amendment No. 1 shall be attached to Agreement and incorporated therein as if fully set forth in the Agreement.
- 7. The recitals to this Amendment No. 1 are incorporated into the Agreement and this Amendment No. 1.
