WHEREAS, County Service Area 15 (CSA No. 15) is responsible for the repair and maintenance of park equipment, such as swings, playground areas, benches, tables and basketball court;

WHEREAS, properly functioning equipment is necessary for the safety and enjoyment of the public,

WHEREAS, CSA No. 15 is also responsible for tree trimming and maintenance within the parks and open space areas;

WHEREAS, a traffic safety issue has been brought up by the local community in Toro Park;

WHEREAS, the Transportation Agency for Monterey County (TAMC), County Public Works, the local school district, the Homeowners' Associations, and CSA 15 have discussed a second pilot project called the "Toro Park Pilot Project Phase 2";

WHEREAS, funding exists in Road Fund's Community Roads Maintenance Program (CRMP) fund of Supervisorial District 5;

WHEREAS, CSA 15 is willing to implement the Toro Park Pilot Project Phase 2;

WHEREAS, for CSA No. 15, it is necessary to increase the FY 2025-26 Adopted Budget appropriations in Fund 056, Appropriation Unit PFP010, by \$100,000, Fund 056, Appropriation Unit PFP010, where the operating transfer is from Road Fund's Community Roads Maintenance Program (CRMP) fund of Supervisorial District 5 and Road Fund has sufficient appropriations available in the adopted budget; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Monterey, as follows:
