

**AMENDMENT No. 2 TO NON-STANDARD AGREEMENT BY AND BETWEEN
COUNTY OF MONTEREY, THROUGH ITS INFORMATION TECHNOLOGY DEPARTMENT &
GRANICUS, LLC**

THIS AMENDMENT is made to the non-Standard AGREEMENT (“AGREEMENT”) dated July 17, 2021, for govAccess Plus Edition Content Management system (CMS) Subscription Services to support Monterey County’s website by and between GRANICUS, LLC, hereinafter “CONTRACTOR,” and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as “COUNTY.”

WHEREAS, the COUNTY and CONTRACTOR amended the AGREEMENT (No. 1) increasing the contract by \$49,500 for a total not to exceed amount of \$94,500, and extended the term through August 31, 2027; and

WHEREAS, the COUNTY and CONTRACTOR wish to amend the AGREEMENT (No. 2) (Q-459227) to increase the contract by \$99,676 for a total contract not to exceed \$194,176, and extend the term through August 31, 2030; and

NOW THEREFORE, the COUNTY and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. The total amount payable by COUNTY to CONTRACTOR under this Agreement shall be amended for a not exceed sum of \$194,176.
2. Term of Agreement shall be amended by updating the term end date to August 31, 2030.
3. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT No. 2 and shall continue in full force and effect as set forth in the AGREEMENT.

A copy of this AMENDMENT No. 2 shall be attached to the original AGREEMENT and AMENDMENT No. 1.
