**AMENDMENT NO. 2
TO PROFESSIONAL SERVICES AGREEMENT
BETWEEN COUNTY OF MONTEREY AND
FONSECA/MCELROY GRINDING COMPANY, INC.**

THIS AMENDMENT NO. 2 to the Professional Services Agreement between the County of Monterey, a political subdivision of the State of California (hereinafter, "County") and Fonseca/McElroy Grinding Company, Inc. (hereinafter, "CONTRACTOR") is hereby entered into between the County and the CONTRACTOR (collectively, the County and CONTRACTOR are referred to as the "Parties").

WHEREAS, CONTRACTOR entered into a Professional Services Agreement with County on May 11, 2012 (hereinafter, "Agreement") to provide on-call rental of a fully operated, fueled and maintained asphalt grinding machine; and

WHEREAS, Agreement was amended by the Parties on September 26, 2012 (hereinafter, "Amendment No. 1") to include on-call rental of a fully operated, fueled and maintained paver machine; and

WHEREAS, additional time and funding are necessary as the County has identified a continued need for on-call rental of a fully operated, fueled and maintained asphalt grinding machine and paver machine at various locations in the County as directed by the County of Monterey, Resource Management Agency – Public Works; and

WHEREAS, the CONTRACTOR'S Price Lists require an update effective July 1, 2013, and

WHEREAS, the Parties wish to amend the Agreement to extend the term to June 30, 2014, to update the Price Lists, and to increase the amount by \$100,000 to continue to provide services identified in the Agreement and as amended by this Amendment No. 2.

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

1. Delete Pages 2 and 3 of "Exhibit A-1 – Scope of Services/Payment Provisions".
2. In all places within the Agreement, any reference to the CONTRACTOR'S 2012 Price Lists in "Exhibit A-1 – Scope of Services/Payment Provisions" are hereby replaced with the CONTRACTOR's 2013 Price Lists in "Exhibit A-2 – 2013 Price Lists".
3. Amend Paragraph 2, "Payments by County", to read as follows:

Amendment No. 2 to Professional Services Agreement
Fonseca/McElroy Grinding Company, Inc.
On-Call Rental of Fully Operated, Fueled and Maintained
Asphalt Grinding and Paver Machines
RMA – Public Works
Term: May 1, 2012 – June 30, 2014
Not to Exceed: \$300,000

County shall pay the CONTRACTOR in accordance with the payment provisions set forth in **Exhibit A-2**, subject to the limitations set forth in this Agreement. The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$300,000.

4. Amend the first sentence of Paragraph 3, "Term of Agreement", to read as follows:

The term of this Agreement is from May 1, 2012 to June 30, 2014, unless sooner terminated pursuant to the terms of this Agreement.
5. Amend Paragraph 4, "Additional Provisions/Exhibits", by adding "Exhibit A-2 – 2013 Price Lists".
6. All other terms and conditions of the Agreement remain unchanged and in full force.
7. This Amendment No. 2 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.

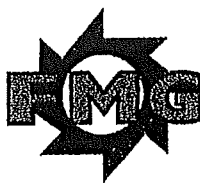
