WHEREAS, California Code of Regulations, Title 17 § 1253 requires that each local health jurisdiction employ public health nursing staff who are qualified and knowledgeable in matters pertaining to health, safety, sanitation and other public health functions and the Public Health Bureau employs seven such supervising public health nurses and twenty-five public health nurses; and

WHEREAS, a local jurisdiction's public health nursing staff shall be under the supervision of a Director of Public Health Nursing and such additional supervisors necessary to provide effective services; and

WHEREAS, the creation of the Director of Public Health Nursing will, in accordance with California Board of Registered Nursing regulations, directly supervise the supervising public health nurse staff during emergencies, during disaster preparedness exercises and drills, and periodically when supervising public health nurses are called upon to provide direct services; and

NOW, THEREFORE, the Monterey County Board of Supervisors, effective December 24, 2016, hereby resolved to approve the following:
