

In December 1970, César Chávez, co-founder of the United Farm Workers, was held in this jail for 20 days for refusing to call off a lettuce boycott, thereby raising national and international attention to farmworkers. This event was considered pivotal in the struggle for farm labor rights.





PRECEDENTS FOR ADAPTIVE REUSE OF JAIL STRUCTURES



Project Name: Allegheny County Prison

Location: Pittsburgh, PA

Year Built: 1884

Year Rehabilitated: 1999-2000

Description: In 1995, Allegheny County opened a new jail, rendering the historic old jail useless. Between 1998-2000, the structure was renovated to house the Family Division of the Allegheny County Court of Common Pleas.



Project Name: Armory Arts Village

Location: Jackson, MI

Year Built: 1839

Year Rehabilitated: 2007

Description: In 2007, the former prison was opened to artists as a living, working, and presentation space.

Extra space is occupied by low-income families and individuals.



Project Name: Old Salem Jail

Location: Salem, MA

Year Built: 1813

Year Rehabilitated: 2009

Description: In 2001, the Old Salem Jail was bought by the city for one dollar. Four years later, New Boston Ventures stepped in and converted the site into residential units, a restaurant, and a museum.

This former convent and prison has been transformed into a music school and concert hall.


1855 Prison now guards Belize's Cultural Treasures



In 2002, Monterey County slated the Old Jail for demolition. The Architectural Heritage Association of Monterey County (AHA) led the public in an effort to preserve the Old Jail for its association with important historic events and its art deco period architectural beauty. AHA, with the help of preservationist Enid Sales,


successfully nominated the Old Jail to the National Register of Historic Places. In 2007, the county hired historic consultants Page and Turnbull to study alternative uses for the Old Jail. On Oct 10, 2017, Monterey County Supervisors approved 5-0 Luis Alejo's proposal to open a Request for Proposal for adaptive reuse of the Old

County Jail where Cesar Chavez was jailed for 20 days in Dec., 1970. In 2013, AHA merged with the Alliance of Monterey Area Preservationists, who now carry on the quest to find the best alternative use for the Old Jail to honor the important agricultural, immigrant, and labor histories of Monterey County.

The significant historic event which occurred in this building was the incarceration of Cesar Chavez in December 1970 for his refusal to call off a lettuce boycott. The fact that Chavez was jailed in pursuing what he believed was a Constitutional right focused national attention on the jail, and on his organizing efforts, and helped to change the course of farm labor working conditions nationwide. This became an event of major national significance.

The jailing and subsequent release of Chavez, along with visits by national civil rights figures Coretta Scott King and Ethel Kennedy, drew national attention to what was previously a regionally instigated boycott. When the California Supreme Court ordered his release from jail on Christmas Eve, 1970, Chavez realized that the grower boycott would become one of his most effective organizing tools — creating a tremendous impact on the market for both grapes and lettuce and putting pressure on growers to sign union contracts.

The Monterey County jail was built in 1931, and is a good example of Gothic Revival architecture during the Art Deco Period. While commonly employed in nineteenth century churches, collegiate buildings, and prisons, this style was not in wide use in the 20th century. Both the administration section of the building and the cellblock were designed in that style by architects Reed and Corlett. Both portions of the building retain a high degree of integrity relative to 1970, the date of Chavez' incarceration.
