Elder and Dependent Adult Abuse Awareness Month in Monterey County.....)

WHEREAS, Elder and Dependent Adult Abuse is a serious and growing crisis in California, with Monterey County seeing sixty-three percent increase in reported cases to Adult Protective Services since 2012; and

WHEREAS, Elder and Dependent Adult Abuse includes physical, sexual, psychological, emotional, financial and material abuse, abandonment, neglect, loss of dignity and respect, and this type of behavior leads to the violation of a human being's most fundamental right to live safely in the least restrictive environment; and

WHEREAS, current estimates suggest a few as one in fourteen cases of Elder and Dependent Adult Abuse is reported because the victims are ashamed, intimidated, experience hopelessness, or is afraid of the perpetrator who stands in the trust relationship; and

WHEREAS, Elder and Dependent Adult victims have a mortality rate three times that of the general population and are three hundred percent more likely to die a premature death; and

WHEREAS, private citizens and public agencies must work to combat crime and violence against Elder and Dependent Adults, prosecuting any and all perpetrators, particularly in the face of continued defunding of vital resources and services; and

WHEREAS, all Californians are strongly encouraged to be proactive in reporting suspected abuse of an Elder or Dependent Adult by contacting their local adult protective service agencies, Long-Term Care Ombudsman, law enforcement agencies, and/or emergency services; and

WHEREAS, June 15th is recognized internationally as World Elder Abuse Awareness Day, first established in 2006 by the United Nations, to raise awareness of Elder and Dependent Adult Abuse and promoting a better understanding of the cultural, social, economic, and demographic issues behind the growing incidence of Elder and Dependent Adult Abuse around the globe;

NOW, THEREFORE BE IT RESOLVED that the Monterey County Board of Supervisors, on behalf of the County and all its citizens thereof, hereby joins the California State Legislature in recognizing the month of **June 2017 as Elder and Dependent Adult Abuse Awareness Month**, therefore, urging residents of Monterey County to take time to acknowledge Elder Abuse as a substantial global public health issue, in need of educational resources, research, and policy changes that are detrimental to the longevity of our entire American society where the only boundary is age.

BE IT FURTHER RESOLVED that this official resolution be presented to the **Monterey County Area Agency on Aging Advisory Council** on June 13, 2017.
