WHEREAS, Janet Brennan is an environmental planner with forty years of experience working for local and regional governments, including experience in air quality, land use, water quality, infrastructure, and hazardous waste planning and environmental review; and

WHEREAS, Janet Brennan retired as Supervising Planner from the Monterey Bay Unified Air Pollution Control District in December 2004. Prior to working for the District, she was a planner for Association of Monterey Bay Area Governments, land use planner for the County of Monterey, Planning Manager for the Ventura County Air Pollution Control District, and Associate Planner and Affirmative Action Officer for the Ventura County Planning Department and Resource Management Agency; and

WHEREAS, Janet Brennan has been active in public interest and community groups since the 1960s, and is currently on the Board of Directors of LandWatch Monterey County and one of its founding members, Board of Directors and Treasurer of Chamber Music Monterey Bay, President of the League of Women Voters of Monterey County (4th term), Vice-Chair of the Advisory Committee for the Monterey Bay Unified Air Pollution Control District, a land use consultant for the California League of Women Voters (LWVC), and Chair of the Carmel Valley Land Use Advisory Committee; and

WHEREAS, Janet Brennan has been a member of the League of Women Voters for over fifty years, and also does environmental consulting for non-profit organizations; and

WHEREAS, Janet Brennan was one of the Monterey County Commission on Women "Women of the Year" in 2013; and

WHEREAS, Janet Brennan's previous activities include President of Carmel Music Social, President of the League of Women Voters of Ventura County, 2005 Monterey County Grand Jury, chair and/or director, Ventura County Manpower Area Planning Council and Private Industry Council; Chair, Ventura County Equal Employment Opportunity Committee, Land Use Director, LWV/California; founding president, Ventura County Environmental Coalition; Vice Foreman, 1971 Ventura County Grand Jury; President of the Ventura Concert Series and member of the Board of Directors for 20 years, and member, PCL Foundation task force which developed a state land use policy, California Land -- Planning for People, 1975; and

WHEREAS, Janet Brennan's publications include: The State's Role in Land Use, 1974, LWV/California (author); Ventura County Tomorrow Plan, 1971 (co-author); Emission Allocation: A Tool for Air Quality Planning and Implementation of Reasonable Further Progress, 1980 (co-author), and has worked with Mary Tsui to document "The Rock Walls of Shasta County"; and

WHEREAS, Janet Brennan is also a watercolorist beginning her course work at Monterey Peninsula College in 1995, her foreign travels have included trips to the United Kingdom and France, and she is planning a trip this fall to Newfoundland to track down some Viking sites; and

WHEREAS, Janet Brennan has a Bachelor's of Arts in Political Science from University of California Berkeley and a Certificate in Environmental Planning from University of Southern California; and


