

**AMENDMENT NUMBER TWO TO SALES ORDER AGREEMENT, E-RATE,

**WHEREAS**, the Assistant Director of the Monterey County Free Libraries executed a Sales Order Agreement, E-Rate, with AMS.NET, Inc. (Contractor) on July 18, 2016; and

**WHEREAS**, the Assistant Director of the Monterey County Free Libraries and Contractor also executed an amendment to the Sales Order Agreement, E-rate, with AMS.NET, Inc. (Contractor) on July 18, 2016, (Amendment No. 1); and

**WHEREAS**, the Sales Order Agreement, E-Rate, with AMS.NET, Inc. and Amendment No. 1 was ratified by the Board of Supervisors of Monterey County on \_\_\_\_\_, 2016; and,

**WHEREAS**, the County and Contractor wish to expand upon the provisions of the Sales Order Agreement, E-Rate, to more fully specify the rights and obligations of the parties;

2. The Sales Order Agreement, E-Rate, is hereby AMENDED to incorporate by reference the AMS.NET Inc. Project Cost Summary set forth in the attached, Exhibit B.
3. All remaining terms, conditions and provisions of the Sales Order Agreement, E-Rate, are unchanged and unaffected by this AMENDMENT No. 2 and shall continue in full force and effect.
4. A copy of this AMENDMENT No. 2 shall be attached to the original Sales Order Agreement, E-Rate executed by the Assistant Director of the Monterey County Free Libraries on July 18, 2016 and ratified by the Monterey County Board of Supervisors, on \_\_\_\_\_, 2016 as well as Amendment No. 1.
