Monterey Regional Waste Management District response:

1. Is your Jurisdiction going to allow self-hauling of "Organics Waste" in your Ordinance per SB 1383? Yes - "Food Waste Self-Hauler" means a Self-Hauler who generates and hauls, utilizing their own employees and equipment, an average of one cubic yard or more per week, or 6,500 pounds or more per quarter of their own Food Waste to a location or facility that is not owned and operated by that Self-Hauler. Food Waste Self-Haulers are a subset of Self-Haulers. Self-haulers may also include landscapers.

2. How will penalties be assessed for violations in your Jurisdiction per SB 1383? This is really up to each jurisdiction but currently is set up as a range.

3. In terms of inspections in your jurisdiction, are you looking to have the Monterey County Environmental Health Bureau conduct the inspections? The District will be issuing an RFP for contamination monitoring for both commercial and residential in the following cities per the draft agreement (which is still a draft and not finalized). "Contamination monitoring in compliance with SB 1383 is to be provided for the Pebble Beach Community Services District and the cities of Carmel, Del Rey Oaks, Marina, Monterey, Pacific Grove, Sand City, and Seaside (the Agencies).
