

## AMENDMENT #9 TO AGREEMENT #A-12200

### AMENDMENT #9 TO AGREEMENT #A-12200 BY AND BETWEEN THE COUNTY OF MONTEREY AND CALIFORNIA FORENSIC MEDICAL GROUP, INC. RETROACTIVE TO SEPTEMBER 30, 2017

**THIS AMENDMENT** is made to the PROFESSIONAL SERVICES AGREEMENT #A-12200 for the provision of medical services to inmates at the Monterey County Adult Correction Facility by and between CALIFORNIA FORENSIC MEDICAL GROUP INC., hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County".

**WHEREAS**, the County and CONTRACTOR first entered into the AGREEMENT on April 1, 2012, by board action, and subsequently amended the AGREEMENT on June 11, 2013 with Amendment #1, on September 14, 2014 with Amendment #1A, on February 1, 2015 with Amendment #2, on June 26, 2015 with Amendment #3, on June 20, 2016 with Amendment #4, on October 5<sup>th</sup>, 2016 with Amendment #5, on February 15, 2017 with Amendment #6, on June 27, 2017 with Ratification Amendment #7, and on August 1, 2017 with Amendment #8; and

**WHEREAS**, the AGREEMENT expired, subject to its terms on September 30<sup>th</sup>, 2017; and

**WHEREAS**, the County and CONTRACTOR wish to amend the AGREEMENT retroactive to September 30<sup>th</sup>, 2017; and

**WHEREAS**, The County and CONTRACTOR wish to further amend the AGREEMENT to extend the AGREEMENT for an additional three (3) month period to finalize contract negotiations.

**NOW THEREFORE**, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. **Paragraph 3, "TERM OF AGREEMENT", shall be amended by removing**, "The term of this Agreement is from April 1, 2012 to September 30, 2017 unless sooner terminated pursuant to the terms of this Agreement", **and replacing it with** "The term of this Agreement is from **April 1, 2012 to December 31, 2017**, unless sooner terminated pursuant to the terms of this Agreement".
2. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
3. A copy of this AMENDMENT shall be attached to the original AGREEMENT dated April 1, 2012.
