Adopt Resolution commending **Deputy David Burnside** upon his retirement from twenty-seven years of public service with the Monterey County Sheriff's Office

**WHEREAS, Deputy David Burnside** was born and raised in Whittier CA; and

**WHEREAS, Deputy David Burnside** served in the United States Marine Corps from 1989 to 1993, and was deployed to the Gulf War (Operation Desert Storm); and

**WHEREAS,** upon being honorably discharged from the Marine Corps, **Deputy David Burnside** worked as a valet parking attendant at a restaurant at night, while putting himself through the police academy during the day; and

**WHEREAS,** upon graduating from the police academy, **Deputy David Burnside** was hired by the Monterey County Sheriff's Office in 1995 and began his career working in the jail; in 1997 he transferred to the patrol division; and

**WHEREAS, Deputy David Burnside** received the Oath of Office from Sheriff Norm Hicks on July 31st, 1995, and over his career, served during the terms of Sheriff Gordon Sonne, Sheriff Mike Kanalakakis, Sheriff Scott Miller, and Sheriff Steve Bernal; and

**WHEREAS, Deputy David Burnside** while assigned to the Enforcement Operations division, had the opportunity to experience many different assignments to include being a member of the Sheriff's Dive Team, and the Sheriff's Search and Rescue Team; and

**WHEREAS, Deputy David Burnside** was one of the very first members of the Monterey County Sheriff's Office "HOST" (Homeless Outreach Safety Team) where he spent countless days building relationships with the unhoused, providing them with responsible decision-making techniques and ultimately providing positive life-changing decisions for those in need of assistance; and

**WHEREAS, Deputy David Burnside** always stayed busy responding to emergencies both on and off duty, while also spending all of his free time with his daughter Elizabeth, coaching her softball teams at Manzanita park for several years, until she was a sophomore at Monte Vista Christian High School.

**WHEREAS, Deputy David Burnside** was a very active and devoted father and is very committed to being involved in our local youth sports community.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors of the County of Monterey on behalf of all residents thereof, acknowledges, commends, and thanks **Deputy**
