## AMENDMENT NO. 1 TO AGREEMENT BY AND BETWEEN COUNTY OF MONTEREY AND Keehan & Partners, Inc.

**THIS AMENDMENT NO. 1** to the Agreement made by and between the County of Monterey, a political subdivision of the State of California (hereinafter referred to as "County"), and Keehan & Partners, Inc., (hereinafter referred to as "CONTRACTOR") with respect to the following.

WHEREAS, on March 13,2024, County and CONTRACTOR entered into an Agreement in the amount of \$82,022 for the term March 13, 2024, through June 30, 2024, for the provision of providing a communication plan for the County of Monterey Tobacco Control Program that integrates work plan goals using State developed assets to bring awareness of smoke-free housing and smoking cessation resources; and

**WHEREAS**, County and CONTRACTOR wish to amend the Agreement to extend the term by one year to June 30, 2025, and to increase the total amount by \$155,795 for a total Agreement amount of \$237,817, due to added services, and replace EXHIBIT A due to the additional services in the Scope of Services.

**NOW THEREFORE**, County and CONTRACTOR hereby agree as follows:

- 1. Paragraph 2, "Payment Provisions", shall be amended by removing "The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$82,022" and replacing it with "The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$237.817.".
- 2. Paragraph 3, "Term of Agreement", shall be amended by removing "The term of this Agreement is from March 13, 2024, to June 30, 2024, unless sooner terminated pursuant to the terms of this Agreement" and replacing it with "The term of this Agreement is from March 13, 2024, to June 30, 2025, unless sooner terminated pursuant to the terms of this Agreement".
- 3. EXHIBIT A-1: SCOPE OF SERVICES/PAYMENT PROVISIONS replaces EXHIBIT A: SCOPE OF SERVICES/PAYMENT PROVISIONS. All references in the AGREEMENT to EXHIBIT A shall be construed to refer to EXHIBIT A-1.
- 4. Except as provided herein, all remaining terms, conditions, and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the Agreement.
- 5. A copy of this Amendment No. 1 shall be attached to the original Agreement executed by County on March 13, 2024.
