# AMENDMENT NO. 1 TO STANDARD AGREEMENT BETWEEN COUNTY OF MONTEREY AND DAVE'S REPAIR SERVICE

THIS AMENDMENT NO. 1 to the Standard Agreement between the County of Monterey, a political subdivision of the State of California (hereinafter, "County") and Dave's Repair Service (hereinafter, "CONTRACTOR") is hereby entered into between the County and the CONTRACTOR (collectively, the County and CONTRACTOR are referred to as the "Parties").

WHEREAS, CONTRACTOR entered into a Standard Agreement with County on October 12, 2012, (hereinafter, "Agreement"); and

WHEREAS, the County desires that CONTRACTOR continue to provide on-call repair services at various County fueling sites; and

WHEREAS, additional time and funding are required to allow the CONTRACTOR to provide new services described as enhanced vapor recovery Dual Point Phase 1 System retrofits and annual testing at various County fueling sites; and

WHEREAS, the Parties wish to amend the Agreement to extend the term to June 30, 2015 and increase the amount by \$62,498.93 for a total amount not to exceed \$112,498.93 to allow CONTRACTOR to continue to provide tasks identified in the Agreement and as amended by this Amendment No. 1.

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

1. Amend Paragraph 1.01 of Section 1.0, "General Description.", to read as follows:

The County hereby engages CONTRACTOR to perform, and CONTRACTOR hereby agrees to perform, the services described in **Exhibits A and A-1** in conformity with the terms of this Agreement. The goods and/or services are generally described as follows: on-call repair services, enhanced vapor recovery Dual Point Phase 1 System retrofits and annual testing at various County fueling sites.

2. Amend Paragraph 2.01 of Section 2.0, "Payment Provisions.", to read as follows:

County shall pay the CONTRACTOR in accordance with the payment provisions set forth in **Exhibits A and A-1**, subject to the limitations set forth in this Agreement. The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of \$112,498.93.

  - The term of this Agreement is from October 1, 2012 to June 30, 2015, unless sooner terminated pursuant to the terms of this Agreement.
- 4. Amend Paragraph 4.01 of Section 4.0, "Scope of Services and Additional Provisions.", by adding "Exhibit A-1, Scope of Services/Payment Provisions".
- 5. All other terms and conditions of the Agreement remain unchanged and in full force.
- 6. This Amendment No. 1 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.
