WHEREAS, Colonel Lisa M. Lamb is married to retired Colonel Patrick A. Lamb and have four daughters; and

WHEREAS, Colonel Lisa M. Lamb grew up in Pittsburgh, Pennsylvania and began her military career with the U.S. Air Force as an enlisted Supply Specialist; and

WHEREAS, Following her four years of service, **Colonel Lisa M. Lamb** attended Christopher Newport University where she earned a Bachelor of Science degree in Business Administration, and an Army ROTC commission as a Second Lieutenant and earned three other graduate degrees: a Master of Business Administration from Southern Connecticut State University, a Master of Public Administration from the University of Michigan, and a Master of Strategic Studies from the United States Army War College; and

WHEREAS, Colonel Lisa M. Lamb's previous assignments include: Director, Secretary of the Joint Staff, at U.S. Africa Command, Stuttgart, Germany; The Pentagon, as Headquarters Department of the Army, Force Integration Officer; 311th Signal Command, Honolulu, as the G37 Branch Chief; United States Forces Afghanistan as the Strategic Movements Branch Chief; 196th Support Battalion, Honolulu as the Battalion Executive Officer; 9th Mission Support Command, Honolulu as the HQ Commandant, G4 Plans Officer and Deputy G4; the University of Michigan, as an Assistant Professor of Military Science for the Army ROTC Detachment, Ann Arbor, Michigan; and the 80th Training Division, G4 Plans and Operations Officer, Richmond, Virginia; and

WHEREAS, Some awards and decorations **Colonel Lisa M. Lamb** received include: the Defense Meritorious Service Medal, the Meritorious Service Medal with Six Oak Leaf Clusters, Army Commendation Medal, Operation Iraqi Freedom/Operation Enduring Freedom Campaign Medals and the Army Staff Badge; and

WHEREAS, Colonel Lisa M. Lamb assumed the position of the Garrison Commander for USAC Fort Hunter Liggett in June of 2021; and

WHEREAS, Colonel Lisa M. Lamb, along with others at Fort Hunter Liggett, donated gifts, and helped coordinate the landing of Mercy Air for the annual Operation Santa event, which brings joy, gifts, and food to hundreds of local families in South Monterey County; and
