WHEREAS, Monterey County desires to provide enough expenditures to maintain Monterey County Cannabis Program processes including administration, compliance and enforcement;

WHEREAS, the CAO-Intergovernmental & Legislative Division manages the Monterey County Cannabis Program; and

WHEREAS, this action results in a financial commitment of \$50,000 in the adopted FY 2019-20 Budget that is needed to support the administrative fee of the California Cannabis Authority.

NOW, THEREFORE, BE IT RESOLVED, the Board of Supervisors of the County of Monterey hereby:

- a. Authorizes the Auditor-Controller to amend the FY 2019-20 adopted budget by increasing appropriations in the amount \$50,000 for the CAO Budget Unit 001-1050-8054-CAO004 (4/5th vote required), and amend the County Administrative Office (CAO) Budget Unit 001-1050-8054-CAO004 to add expenditure for California Cannabis Authority; and
- b. Authorizes the Auditor-Controller’s Office to incorporate approved modifications in the FY 2019-20 Adopted Budget.
