ORDINANCE NO. 5233

**AN ORDINANCE OF THE COUNTY OF MONTEREY, STATE OF CALIFORNIA,
AMENDING SECTIONS 12.24.010 AND 12.24.020 OF THE MONTEREY COUNTY
CODE RELATING TO THROUGH HIGHWAYS AND STOP INTERSECTIONS ON
COUNTY HIGHWAYS.**

County Counsel Summary

This ordinance amends section 12.24.010 to modify the portion of Old Stage Road to be designated as a through highway. This ordinance also amends section 12.24.020 of the Monterey County Code to establish a four-way stop intersection at Old Stage Road and Old Natividad Road in the Salinas area of the unincorporated area of the County of Monterey.

The Board of Supervisors of the County of Monterey ordains as follows:

SECTION 1. PURPOSE AND FINDINGS. Pursuant to Article XI, section 7 of the California Constitution, the County of Monterey may adopt and enforce ordinances and regulations not in conflict with general laws to protect and promote the public health, safety, and welfare of its citizens. California Vehicle Code section 21354 authorizes the County of Monterey to designate any highway under its jurisdiction as a through highway and to erect stop signs at all entrances thereto, or to designate any intersection under its exclusive jurisdiction as a stop intersection and erect stop signs at one or more entrances thereto.

SECTION 2. Section 12.24.010 of the Monterey County Code is amended to delete the following paragraph:

Old Stage Road from State Highway 101 generally northerly to Hebert Road, except at the intersection with Associated Lane;

SECTION 3. Section 12.24.010 of the Monterey County Code is amended to add the following paragraphs:

Old Stage Road from State Highway 101 generally northerly to the intersection with Williams Road, except at the intersection with Associated Lane;

Old Stage Road from a point 1.75 miles generally northerly of the intersection with Williams Road, generally northerly to the intersection with Hebert Road, except at the intersection with Old Natividad Road;

SECTION 4. Section 12.24.020 of the Monterey County Code is amended to add the following paragraph:

Intersection of Old Stage Road and Old Natividad Road. Stops required at all four entrances to the intersection.

SECTION 5. This ordinance shall become effective on the thirty-first day following its adoption.


