AMENDMENT #3 TO COUNTY OF MONTEREY AGREEMENT FOR PROFESSIONAL SERVICES BETWEEN COUNTY OF MONTEREY

& BAGLEY ENTERPRISES, INC.

THIS AMENDMENT No. 3 is made to the Professional Services Agreement ("AGREEMENT") by and between Bagley Enterprises, Inc. ("CONTRACTOR"), and the County of Monterey, a political subdivision of the State of California ("County").

WHEREAS, on or about January 5, 2010, County and CONTRACTOR entered into a Professional Services Agreement for the provision of quarterly site inspection services, miscellaneous repairs of used oil and filter collection equipment for existing and new equipment, and to provide additional equipment as needed for the period November 1, 2009 through October 31, 2012; and

WHEREAS, on or about January 29, 2011, the County and CONTRACTOR entered into and executed AMENDMENT No. 1 to amend Exhibit B—site Inspection Locations; and

WHEREAS, on or about March 1, 2012, the County and CONTRACTOR entered into and executed AMENDMENT No. 2 to extend the term of the agreement to June 30, 2013, increase the amount payable to CONTRACTOR for the services to provide during the extension period, additional services to be provided, and to update the list of site inspection location.

WHEREAS, County and CONTRACTOR wish to amend the AGREEMENT to increase the amount payable to CONTRACTOR for the services to be provided through June 30, 2013.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

- 1. Section 2, "PAYMENTS BY COUNTY," shall be amended by adding: Increase amount payable to CONTRACTOR by \$35,000, total sum not to exceed \$130,000.
- 2. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
- 3. A copy of AMENDMENT No. 3 shall be attached to the original AGREEMENT dated January 5, 2010.
