**RENEWAL AND AMENDMENT NO. 2
TO THE SERVICES AGREEMENT
BETWEEN NATIVIDAD MEDICAL CENTER (COUNTY OF MONTEREY) AND
INFO IMAGE OF CALIFORNIA INC.**

THIS RENEWAL to the County of Monterey Agreement for Services (hereinafter, "RENEWAL") is made and entered into, by and between the County of Monterey, a political subdivision of the State of California, on behalf of Natividad Medical Center, an acute care hospital (hereinafter, "County"), and Info Image of California Inc. (hereinafter, "CONTRACTOR") (collectively, the County and CONTRACTOR are referred to as the "Parties.").

WHEREAS, the Parties had previously entered into an Agreement for Services (hereinafter, "Agreement"), on June 10, 2010; and

WHEREAS, that Agreement expired on May 31, 2013; and

WHEREAS, the County and Contractor amended the Agreement previously on July 1, 2012 via Amendment No.1; and

WHEREAS, the Parties wish to renew the Agreement on the same or similar terms, beginning July 1, 2014 and increase the amount payable by \$144,000 to continue to provide services associated with Medical Bill Mailing Services within the County of Monterey.

NOW THEREFORE, the Parties agree as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in Agreement, except as specifically set forth below.

1. The term of this RENEWAL is from July 1, 2014 to June 30, 2016 unless sooner terminated pursuant to the terms of this RENEWAL, or extended in writing.
2. Contractor will continue to provide NMC with the same scope of services as stated in the original Agreement (No. A-12226/ MYA459).
3. County shall pay the CONTRACTOR in accordance with the payment provisions set forth in Renewal and Amendment No. 2, subject to the limitations set forth in this RENEWAL. The total amount payable by County to CONTRACTOR shall not exceed the sum of \$324,000.
4. If there is any conflict or inconsistency between the provisions of Agreement, or this RENEWAL, the provisions of this RENEWAL shall govern.




