### Other Board Matters

9. Board Comments

Supervisor Chris Lopez shared the fair in King City will be going on this weekend so please come down and although the rain is coming in it will at least water everything down before the weekend so it should be a fun time at the Salinas Valley Fair. He will also be joining the festivities and can be found in the auction ring Saturday morning with Congressman Jimmy Panetta helping sell some of the animals for the kids. Last night he had a great meeting in Soledad. It was a community meeting where about 40 people turned out to share their concerns about things happening in town and in the surrounding communities so that was great. They will have another one tomorrow night in Chualar and then next week on the 21st they will be in Greenfield so the listening continues. The only other item he had was to invite the Supervisors to the midnight barbeque.

Supervisor Mary L. Adams commented tomorrow, Wednesday, Laguna Seca is hosting the kickoff for this leg of the Amgen Tour bike race which is pretty exciting and she hopes the weather will cooperate.

Supervisor Luis A. Alejo expressed a belated Mother's Day wish to all the County employees, Moms, and Grandmas. He acknowledged all their tremendous work and apologized for the lateness in his sentiment. He also shared it was beautiful to spend time with families over the weekend. He also wanted to acknowledge the work the City of Salinas is doing. First, there was a meeting at the Filipino Community Hall regarding the Chinatown Vibrancy Plan and there has been a lot of work done on the Alisal Vibrancy Plan. He shared it's nice to know they are also focusing on Chinatown as it is one of the most depressed areas in the city. The plan is to revitalize that area and bring culture, art, and music to its center. Community residents and local businesses provided input and there will be a few more meetings held. He looks forward to the final product and implementation of the plan to revitalize this historic part of the city. Lastly, he wanted to congratulate our local boxing champion,

Ruben Villa, who won last Friday night. He headlined the fights on Showtime, for the first time. He won a unanimous decision and proved his record 16 and 0 winning an additional Regional title the WBO International Featherweight title on top of the title he already had which was the WBO Youth Championship title. He beat Luis Alberto Lopez from Mexicali who was 17 and 0. Lopez is another young man with a great record as well. This Saturday from 12:00 p.m. to 2:00 p.m. Villa is hosting a community celebration, at his boxing gym, at 635 Sanborn Place, Suite 21. He welcomes the community to come to join in the celebration. Let's all congratulate him as one of the young role models from our community who are excelling in sports. Also, at the same time giving back to the community. We cannot have enough role models like this in Salinas. Again, congratulations to him and his family as well as to Coach Garcia who has coached many young people in the community. It's not just young men who are coming up the ranks. There are also some young amazing women boxers that will be fighting for some titles as well.

Supervisor Jane Parker commented on the safe street demonstrations going on for the first two weeks in Seaside then being rolled out this week in Marina with paint on the sidewalks and close to the sidewalks to test out plans for how the infrastructure might be built to make it safer for kids walking to school and other pedestrians. Today was the opening day event at Epiphany Lutheran Episcopal Church in Marina, tomorrow it's at the Crumpton Bike and Walk to school day that will start at Epiphany Lutheran Church at Carmel and California Avenues and then on Thursday it's the Bike and Walk to school day for Marina Vista again meeting at Epiphany Lutheran Church and those are starting at 7:00 a.m. in the morning and get going at 7:30 a.m. Members of the community are encouraged to walk or bicycle through the demonstration at those times or at other times to give feedback on what they think of how they are and how they work. This is part of the safe routes to schools grants from the Transportation Agency. She also mentioned that someone who got her start in this area, Lisa Rayville, was here as an Americorps volunteer working in harm reduction at the needle exchange on Market Street. She has been working at the harm reduction action center in Denver, Colorado for the last 10 years and she was just being honored for her work and as a national leader in harm reduction. She's been leading the way on legislation at the local and state-level in Colorado for clean needle exchange, the lock zones availability and the provision of sanitary supplies to injection drug users. Their agency provides other aspects of safety health and a connection to support services for that population, so this coming Saturday is Lisa Rayville Day in Denver, Colorado. She is pleased that someone who started here locally is getting so much recognition and doing such great work. She was also thinking about Mother's Day. She wished people a Happy Mother's Day and didn't realize that 84% of women become mothers that's a pretty good statistic. She gave a shout out to women who go forward and have children. She's not a mother herself so she has a great deal of admiration for those that are. She also appreciated her mother because without all of our mothers we wouldn't be here today.

Supervisor John M. Phillips shared they celebrated Mother's Day with a special brunch hosted at Rancho Cielo. They served about 250-300 people who were county employees, farm and field workers that reflected a cross-section of our community. Over the weekend, he mentioned, he was in Parkfield and was trying to take a call. By the way, Parkfield is where he tried the last cattle rustling case ever tried in the state of California. In his attempt to take the call he was unable to as there was no phone service. He told the people down

there that he was going to tell the Supervisor to work on this issue.

Supervisor Mary L. Adams also added she neglected to wish Supervisor Jane Parker a Happy Birthday on May 11th.
