# AMENDMENT NO. 3 TO PROFESSIONAL SERVICES AGREEMENT BETWEEN Versaworks Inc. AND THE NATIVIDAD MEDICAL CENTER FOR

### **Professional Information Technology Services**

This Amendment No. 3 to Professional Services Agreement ("Agreement"), dated November 1, 2010, is entered into by and between the County of Monterey, on behalf of Natividad Medical Center ("NMC"), and Versaworks Inc. (Contractor), with respect to the following:

#### RECITALS

WHEREAS, the County and Contractor amended the Agreement previously on July 1, 2011 via Amendment No. 1, and on July 1, 2012 via Amendment No. 2; and

WHEREAS, the County and Contractor wish to amend the Agreement to extend the term end date to allow for existing services to continue; and

WHEREAS, the County and Contractor wish to amend the Agreement to increase the amount of the Agreement because of the term extension and the amount payable for services rendered.

#### AGREEMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

- 1. Exhibit A to the Agreement is replaced with <u>Amendment-3 to Exhibit A</u>, attached to this Amendment. All references in the Agreement to Exhibit A shall be construed to refer to <u>Amendment-3 to Exhibit A</u>.
- 2. Section 2. "PAYMENTS BY NMC" shall be amended by removing, "The total amount payable by NMC to CONTRACTOR under this Agreement shall not exceed the sum of \$832,900." and replacing it with "The total amount payable by County to CONTRACTOR under Agreement No. (MYA524) shall not exceed the total sum of \$8,829,374 for the full term of the Agreement".
- 3. Section 2. "TERM OF AGREEMENT" shall be amended by removing, "The term of this Agreement is from November 1, 2010 to June 30, 2011 unless sooner terminated pursuant to this Agreement" and replacing it with "The term of this Agreement is November 1, 2010 to June 30, 2015 unless sooner terminated pursuant to this Agreement".

- 4. Except as provided herein, all remaining terms, conditions and provisions of the Agreement and Amendment Nos. 1 and 2 are unchanged and unaffected by this Amendment No. 3 and shall continue in full force and effect as set forth in the Agreement.
- 5. A copy of this Amendment No. 3 and all previous amendments shall be attached to the original Agreement (No. MYA524).
- 6. The effective date of this Amendment is July 1, 2013.

# **RECOMMENDATION:**

It is recommended the Board of Supervisors authorize the Purchasing Manager for Natividad Medical Center (NMC) to execute Amendment No. 3 to the Agreement (A-11891) with Versaworks Inc. for Professional Information Technology Services at NMC, extending the Agreement to June 30, 2015 and adding \$3,750,724 for a revised total Agreement amount not to exceed \$8,829,374 in the aggregate.

# **SUMMARY/DISCUSSION:**

As NMC continues to enhance its information technology capabilities in the Electronic Medical Record and IT infrastructure, a need has been identified for additional technical clinical and non-clinical resources. The recommendation is to engage Versaworks, a company with a proven track record for providing highly competent information technology services. Attached is a list of key accomplishments performed by Versaworks over the last twelve months.

Over the next two years, Versaworks will provide both clinical and non-clinical technical resources which will include but not be limited to, a principle project manager, IT management consultant, senior systems engineer, network & security engineer, senior database administrator and systems integration implementation specialist. In addition, Versaworks will provide software solutions to support Natividad's goals to achieve Meaningful Use Stage II. Please see attached Statement of Work (SOW) for more detail.

Versaworks is committed to NMC's long range IT roadmap and by engaging Versaworks, important strategies and goals will be met.

County Counsel has reviewed and approved this Amendment No. 3 as to legal form and risk provisions Auditor-Controller has reviewed and approved this Amendment No. 3 as to fiscal provisions The Amendment No. 3 has also been reviewed and approved by Natividad Medical Center's Board of Trustees.

# **FINANCING:**

The cost for this Amendment No. 3 is \$3,750,724 and is included in the Fiscal Year 2013/2014 Recommended Budget. There is no impact to the General Fund.
