AMENDMENT NO. 2 TO SERVICES AGREEMENT BETWEEN GALLUN SNOW ASSOCIATES, INC AND NATIVIDAD MEDICAL CENTER FOR INTERIOR DESIGN SERVICES

This Amendment No. 2 to the Services Agreement ("Agreement") which was effective on August 1, 2013 is entered into by and between the County of Monterey (hereinafter "COUNTY"), on behalf of Natividad Medical Center (hereinafter "NMC"), and **Gallun Snow Associates**, **Inc.**, (hereinafter "CONTRACTOR"). Collectively, COUNTY, NMC and CONTRACTOR are referred to as the "Parties", with respect to the following:

RECITALS

WHEREAS, the County of Monterey on behalf of Natividad Medical Center and Gallun Snow Associates, Inc. entered into an Agreement pursuant to the Request for Qualifications (RFQ #9600-48) for interior design services with a term August 1, 2013 through June 30, 2018 and a total Agreement amount not to exceed \$750,000; and

WHEREAS, the Parties amended the Agreement on April 28, 2016 via Amendment No. 1 to update the Scope of Services (Exhibit A of original Agreement) attached to the original Agreement to add billing rates for years 2016 through 2018 with "Exhibit A-1 as per Amendment No. 1" attached to Amendment No. 1, and with no change to the original Agreement term of August 1, 2013 through June 30, 2018 or to the original Agreement amount of \$750,000; and

WHEREAS, the Parties currently wish to amend the Agreement to extend it for an additional twenty (20) month period through April 30, 2020 for a revised full Agreement term of August 1, 2013 through April 30, 2020 and to add additional services to the Scope of Services for the completion of the Radiology Upgrade Project attached hereto as "Exhibit A-2 per Amendment No. 2" with an increase of \$294,000 for a revised total Agreement amount not to exceed \$1,044,000.

AGREEMENT

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the original Agreement and in Amendment No 1 incorporated herein by this reference, except as specifically set forth below.

1. Section 2/Paragraph titled, "PAYMENTS BY NMC" shall be amended by removing:

"NMC shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A-1, subject to the limitations set forth in this Agreement. The total amount payable by NMC to CONTRACTOR under this Agreement shall not exceed the sum of \$750,000."

and replacing it with:

"NMC shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A-2, subject to the limitations set forth in this Agreement. The total amount payable by NMC to CONTRACTOR under this Agreement shall not exceed the sum of \$1,044,000."

2. The first sentence of Section 3 /Paragraph titled, "TERM OF AGREEMENT" shall be amended by removing:

"The term of this Agreement is from August 1, 2013 through June 30, 2018 unless sooner terminated

pursuant to the terms of this Agreement."

and replacing it with:

"The term of this Agreement is from August 1, 2013 through April 30, 2020 unless sooner terminated pursuant to the terms of this Agreement."

3. <u>Section 4/ Paragraph titled, "SCOPE OF SERVICES AND ADDITIONAL PROVISIONS/EXHIBITS" shall be amended by removing the following:</u>

"The following attached exhibits are incorporated herein by reference and constitute a part of this Agreement:

and replacing it with:

- 4. Except as provided herein, all remaining terms, conditions and provisions of the original Agreement are unchanged and unaffected by this Amendment No. 2 and shall continue in full force and effect as set forth in the original Agreement and in Amendment No. 1.
- 5. A copy of this Amendment No. 2 shall be attached to the original Agreement.
- 6. This Amendment No. 2 shall be effective when signed by both Parties.
