WHEREAS, the California Environmental Quality Act (Public Resources Code section 21000 et seq., “CEQA”) requires that a Mitigation Monitoring and Reporting Plan be adopted for every land use project approved subject to mitigation measures; and

WHEREAS, the California Environmental Quality Act and its implementing regulations in Title 14 of the California Code of Regulations commencing at Section 15000 et seq., (“CEQA Guidelines”) were adopted by the State of California to provide administrative procedures to implement CEQA; and

WHEREAS, the County of Monterey has adopted local guidelines for implementing the California Environmental Quality Act by Ordinance of the Board of Supervisors (Ordinance No. 04087) (Monterey County CEQA Guidelines); and

WHEREAS, the Monterey County CEQA Guidelines incorporate the same provisions of the California Environmental Quality Act that require adoption of a Mitigation Monitoring and Reporting Plan; and

WHEREAS, in response to a Settlement Agreement between the Save Our Peninsula Committee and the County of Monterey in 2000, the Board adopted procedures for a County of Monterey Condition of Approval and Mitigation and Monitoring and Reporting Program (“Procedures”); and

WHEREAS, on January 24, 2012, the County amended the Procedures by Board of Supervisors’ Resolution No. 12-021, including the requirement to prepare annual reports relating to the status of compliance with mitigation measures, any related code enforcement actions, and any proposed action to modify conditions of approval for land use projects approved in the previous calendar year; and

WHEREAS, with the goal of improving its compliance with CEQA, its related mitigation monitoring and reporting procedures, and the ability of the public to review and monitor compliance with CEQA and its own procedures, the County further amended the Procedures on December 6, 2014 by Board of Supervisors’ Resolution No. 14-364 (“Amended Program”); and

WHEREAS, with the goal of improving its compliance with CEQA, its related mitigation monitoring and reporting procedures, and the ability of the public to review and monitor compliance with CEQA and its own procedures, the County further amended the Procedures on February 14, 2017 by Board of Supervisors’ Resolution No. 17-049 (“Amended Program”); and

WHEREAS, Section III.E of the Amended Program require that the annual report be considered by the Board of Supervisors at a noticed public hearing; and

WHEREAS, notice of the June 27, 2016 public hearing at the Board of Supervisors on the annual report, as required by the Amended Program, was published in the *Monterey County Weekly* on June 15, 2017; and

WHEREAS, in compliance with Section 9 of the Settlement Agreement (dated September 16, 2011), Save Our Peninsula Committee's representative was provided notice of the Monterey County Board of Supervisors' public hearing noticed for June 27, 2017 and a copy of the annual report; and

WHEREAS, on June 16, 2017, County staff provided a staff report, for the public and Board of Supervisors' consideration, that provided the annual report for 2016, as required by the Amended Program; and

WHEREAS, the Board of Supervisors was scheduled to hold a duly noticed public hearing on June 27, 2017 and continued the hearing to August 29, 2017 to consider the 2016 Annual Report and took public testimony;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Monterey that the Annual Report on the status of compliance with Condition of Approval/ Mitigation Monitoring and Reporting Plans for all land use projects with mitigation measures approved by the County of Monterey in 2016, attached hereto and incorporated herein by reference is hereby accepted.


