**WHEREAS**, On July 28, 2020, the Board of Supervisors received a report by Citygate Associates that provided 76 recommendations, including splitting the Resource Management Agency (RMA) into two departments;

**WHEREAS**, the split of the RMA included splitting the Environmental Services Team, and the position of Senior Hydrologist placed in the newly formed Public Works, Facilities, and Parks (PWFP) Department;

**WHEREAS**, a lead (supervisory) position with expertise in water resources hydrology is needed in the newly formed Housing and Community Development (HCD) Department;

**WHEREAS**, within the HCD organization the currently vacant position of Civil Engineer would be in a supervisory position over the Development Review and Stormwater Pollution Prevention Inspection (SPPI) team, a role previously held by a Senior Hydrologist;

**WHEREAS**, the HCD does not require an engineer to oversee the Development Review and SPPI team, and does require the expertise of an Associate Water Resources Hydrologist; and

**WHEREAS**, the position of HCD Associate Water Resources Hydrologist will replace the Civil Engineer position and will be a full-time position with a salary range of \$86,724 - \$118,452, resulting in annualized savings.

**NOW, THEREFORE, BE IT RESOLVED THAT** by the Board of Supervisors in and for the County of Monterey as follows:

1. The Housing and Community Development Department Budget Unit Environmental Services 001-3000-8531-RMA110 is amended to reallocate one (1) Civil Engineer to one (1) Associate Water Resources Hydrologist as indicated below:
