AMENDMENT NO. 1 TO STANDARD AGREEMENT BETWEEN COUNTY OF MONTEREY AND ERROL L. MONTGOMERY & ASSOCIATES, INC.

THIS AMENDMENT NO. 1 to the Standard Agreement between the County of Monterey, a political subdivision of the State of California (hereinafter, "County"), and Errol L. Montgomery & Associates, Inc., (hereinafter, "CONTRACTOR") is hereby entered into between the County and the CONTRACTOR (collectively, the County and CONTRACTOR are referred to as the "Parties") as of the last date opposite the respective signatures.

WHEREAS, CONTRACTOR entered into a Standard Agreement with County on March 4, 2020 (hereinafter, "Agreement") to provide professional hydrogeologic services for completing the Salinas Valley Groundwater Basin Investigation through June 30, 2021, for an amount not to exceed \$233,260.00; and

WHEREAS, County has a continued need for services beyond the original term; and,

WHEREAS, the U.S. Geological Survey is in the process of updating their historical conditions model and has an expected completion in April 2021; and

WHEREAS, these updates will assist CONTRACTOR in completing their reassessment and evaluation of future conditions; and

WHEREAS, the Parties wish to amend the Agreement to extend the contract term by one additional year to June 30, 2022, with no increase in the not to exceed amount of \$233,260.00 to allow CONTRACTOR to continue to provide services identified in the Agreement and as amended by this Amendment No. 1.

NOW THEREFORE, the Parties agree to amend the Agreement as follows:

1. Amend the first sentence of Paragraph 3, "Term of Agreement," to read as follows:

The term of this Agreement is from <u>April 1, 2020</u> to <u>June 30, 2022</u> unless sooner terminated pursuant to the terms of this Agreement.
