WHEREAS, March 2021, Monterey County was awarded \$28,531,233.70 in Round One of Emergency Rental Assistance block grant funding from both the U.S. Treasury and the State of California which has to be expended by September 30, 2022; and

WHEREAS, Monterey County began the Emergency Utility and Rental Assistance Program on March 2021 partnering with United Way of Monterey County to administer a program that targets low-income residents adversely impacted by the COVID-19 crisis who are at risk of becoming homeless; and

WHEREAS, Monterey County was awarded \$22,317,870.04 in Round Two of Emergency Rental Assistance block grant funding from both the U.S. Treasury and the State of California which has to be expended by September 30, 2025; and

WHEREAS, in FY 2021-22, the Program is estimated to expend \$38.6 million for the current budget fiscal year and only \$18 million was appropriated; and

WHEREAS, an increase in appropriations and revenues are required in the Social Services Community Programs FY 2021-22 Adopted Budget 001-5010-SOC004-8258 in the amount of \$20,650,000; and

WHEREAS, the Department of Social Services is projecting that both rounds of funding totaling \$50,849,093.74 will be expended by December 2022; and

WHEREAS, the Board of Supervisors will need to authorize and direct the Auditor Controller to amend the FY 2021-22 Adopted Budget by increasing appropriations and revenues by \$20,650,000 in Social Services – Community Program Budget Unit 001-5010-SOC004-8258.

NOW, THEREFORE, BE IT RESOLVED, the Board of Supervisors of the County of Monterey hereby:

- a. Approved an increase in appropriations and revenues of \$20,650,000 for the Social Services Community Programs Budget Unit 001-5010-SOC004-8258 FY 2021-22 Adopted Budget to provide emergency rental & utility assistance to residents in Monterey County (4/5^{ths} vote required); and
- b. Authorized and directed the Auditor-Controller to amend the FY 2021-22 Adopted Budget by increasing appropriations and revenues by \$20,650,000 in Social Services Community Program Budget Unit 001-5010-SOC004-8258 (4/5ths vote required).
