WHEREAS, a classification and base wage compensation study of the Legal Secretary-Confidential and Senior Legal Secretary-Confidential positions in the County Counsel's Office was conducted by Koff & Associates and completed in August 2019; and

WHEREAS, the classification and base wage compensation recommendations were partially implemented in December 2019 with the intent to create an entry level classification of Legal Secretary I, retitle the Legal Secretary to Legal Secretary II and to consolidate the Senior Legal Secretary with the Legal Secretary III at a later time; and

WHEREAS, it is recommended to adjust the base wage of the Legal Secretary series in alignment with the salary established when the Legal Secretary III classification was created which was set at approximately 13.12% above the Senior Legal Secretary at top stop and to maintain the spread within the series; and

WHEREAS, the Human Resources Department conducted base wage compensation studies of the Legal Process Clerk series, Legal Typist, Legal Assistant, and the Legal Support Coordinator classifications which determined the benchmark classifications of Legal Process Clerk is 27.43%, the Legal Typist 17.38% and the Legal Assistant 16.10% below the market of the County's comparable agencies and are recommended to be adjusted by the approximate percentage identified at top step; and

WHEREAS, in reviewing the allocated positions of the classifications, it was determined the Legal Support Coordinator and Senior Legal Process Clerk have not been allocated in over a decade, no longer meet the needs of the County and are recommended to be abolished; and

WHEREAS, to implement the recommendations, the actions require the Personnel Policies and Practices Resolution No. 98-394 Appendix A and B to be amended; NOW, THEREFORE,

BE IT RESOLVED by the Board of Supervisors in and for the County of Monterey as follows:
