FOURTH AMENDMENT TO PROFESSIONAL AND CALL COVERAGE SERVICES <u>AGREEMENT</u>

THIS FOURTH AMENDMENT TO PROFESSIONAL AND CALL COVERAGE SERVICES AGREEMENT (the "Amendment") is made and entered into as of January 1, 2022, by and between COUNTY OF MONTEREY ("County") on behalf of NATIVIDAD MEDICAL CENTER ("Hospital"), and Muralidhara R. Raju, M.D., an individual ("Contractor") with respect to the following:

RECITALS

- A. County owns and operates Hospital, a general acute care teaching hospital facility and Level II Trauma Center located in Salinas, California under its acute care license.
- B. Contractor and Hospital have entered into that certain Professional and Call Coverage Services Agreement dated March 1, 2016, amendment effective January 1, 2018, September 1, 2019 and January 1, 2021 (collectively the "Agreement") pursuant to which Contractor provides Specialty Services.
- C. Hospital and Contractor desire to amend the Agreement to extend the term by twelve months.

AGREEMENT

IN CONSIDERATION of the foregoing recitals and the mutual promises and covenants contained herein, Hospital and Contractor agree as follows:

- 1. **<u>Defined Terms</u>**. Capitalized terms not otherwise defined herein shall have the meaning ascribed to them in the Agreement.
- 2. <u>Section 5.1</u>. Section 2.1 to the Agreement is hereby amended and restated to read in its entirety as follows:

"<u>Term.</u> This Agreement shall become effective on March 1, 2016 (the "Effective Date"), and shall continue until December 31, 2022 (the "Expiration Date"), subject to the termination provisions of this Agreement."

- 3. <u>Counterparts</u>. This Amendment may be executed in one or more counterparts, each of which shall be deemed to be an original, but all of which together shall constitute one and the same instrument.
- 4. <u>Continuing Effect of Agreement</u>. Except as herein provided, all of the terms and conditions of the Agreement remain in full force and effect from the Effective Date of the Agreement.
- 5. **Reference**. After the date of this Amendment, any reference to the Agreement shall mean the Agreement as amended by this Amendment.
