WHEREAS, one position would be responsible for managing OES training; and,

**WHEREAS**, these positions are critically essential to allow the County to meet its emergency response obligations effectively and efficiently

**NOW, THEREFORE, BE IT RESOLVED THAT** the Board of Supervisors, in and for the County of Monterey, hereby:
