Amendment No. 3 To 340B Contract Pharmacy Services Agreement By and Between County of Monterey and Walgreen Co.

THIS AMENDMENT No. 3 ("Amendment") is made and entered into, by and between Walgreen Co., hereinafter ("Walgreens"), and the County of Monterey, a political subdivision of the State of California, on behalf of its Health Department, hereinafter referred to as ("Covered Entity").

RECITALS:

WHEREAS, the Covered Entity and Walgreens have heretofore entered into an Agreement for 340B contract pharmacy services provided by Walgreens for the period of March 25, 2014 to March 25, 2019; and

WHEREAS, on June 15, 2015, the Covered Entity and Walgreens entered into an executed Amendment No. 1 to delete the terms Central Inventory Replenishment Sites ("CIRS") and Distribution Center Locations in the 340B Agreement; and

WHEREAS, on March 26, 2019, the Covered Entity and Walgreens entered into an executed Amendment No. 2 to extend the term of the Agreement for two (2) additional years, for a new term of March 25, 2014 to March 31, 2021; and

WHEREAS, the Covered Entity and Walgreens wish to amend the Agreement to extend the term of the Agreement as specified below.

NOW THEREFORE, the Covered Entity and Walgreens hereby agree to amend the Agreement, as follows:

- 1. **SECTION 7.1, "TERM**", shall be extended for an additional one (1) year period to March 31, 2022 for a new term of March 25, 2014 to March 31, 2022.
- 2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment and shall continue in full force and effect as set forth in the Agreement.
- 3. A copy of this Amendment shall be attached to the Agreement.
- 4. The effective date of this Amendment is April 1, 2021.
