Amendment No. 2 To 340B Contract Pharmacy Agreement By and Between County of Monterey and Walgreen Co.

THIS AMENDMENT No. 2 ("Amendment") is made and entered into, by and between Walgreen Co., hereinafter ("Walgreens"), and the County of Monterey, a political subdivision of the State of California, on behalf of its Health Department, hereinafter referred to as "County".

RECITALS:

WHEREAS, the County and Walgreens wish to amend the Agreement to extend the term of the Agreement as specified below.

NOW THEREFORE, the County and Walgreens hereby agree to amend the Agreement, as follows:

- 1. SECTION 7.1, "TERM", shall be extended for an additional two (2) year period to March 31, 2021 for a new term of March 25, 2014 to March 31, 2021.
- 2. **SECTION 8.11, "NOTICE"**, shall be updated as follows:
