AMENDMENT NO. 2 TO SERVICES AGREEMENT BETWEEN NEOGENOMICS LABORATORIES, INC. AND NATIVIDAD MEDICAL CENTER FOR PATIENT SPECIMAN TESTING

This Amendment No. 2 to the Services Agreement ("Agreement") which was effective on August 1, 2017 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (hereinafter "NMC"), and NeoGenomics Laboratories, Inc. (hereinafter "CONTRACTOR"); (collectively, the County, NMC and CONTRACTOR are referred to as the "Parties"), with respect to the following:

RECITALS

WHEREAS, the Agreement was executed for patient specimen testing services with a term August 1, 2017 through July 31, 2020 and a total Agreement amount not to exceed \$25,000; and

WHEREAS, NMC and CONTRACTOR amended the Agreement on July 17, 2019 via Amendment No. 1 to add an additional \$75,000, thereby increasing the total Agreement amount to \$100,000 with no change to the scope of work, billing rates, or term of the Agreement August 1, 2017 through July 31, 2020, and to include a Business Associate Agreement as an attachment to this Agreement.

WHEREAS, NMC and CONTRACTOR currently wish to amend the Agreement to extend it for an additional two (2) year period (August 1, 2020 through July 31, 2022) for a revised full agreement term of August 1, 2017 through July 31, 2022 to allow for services to continue with no changes to the scope of work or changes to the agreement amount.

AGREEMENT

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Original Agreement and Amendment No. 1 incorporated herein by this reference, except as specifically set forth below.

1. The first sentence of <u>Section 3 /Paragraph titled</u>, "TERM OF AGREEMENT" shall be amended to the following:

"The term of this Agreement is from August 1, 2020 through July 31, 2022 unless sooner terminated pursuant to the terms of this Agreement."

- 2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 2 and shall continue in full force and effect as set forth in the Agreement and in Amendment No. 1.
- 3. A copy of this Amendment No. 2 shall be attached to the Agreement.
- 4. This Amendment No. 2 shall be effective when signed by both parties.
