Authorize the Chief Executive Officer for Natividad Medical Center (NMC) or his designee to execute amendment No. 3 to the agreement (A-13971) with Spin Recruitment Services pursuant to RFP #9600-78 for advertising recruitment services, extending the agreement an additional one (1) period year (January 1, 2023 through December 31, 2023) for a revised full agreement term of July 1, 2018 through December 31, 2023, and adding \$325,000 for a revised total agreement amount not to exceed \$1,225,000.

# AMENDMENT NO. 3 TO SERVICES AGREEMENT BETWEEN SPIN RECRUITMENT INC. AND NATIVIDAD MEDICAL CENTER FOR ADVERTISING RECRUITMENT SERVICES

This Amendment No. 3 to the Services Agreement ("Agreement") which was effective on July 1, 2018 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (hereinafter "NMC"), and Spin Recruitment Inc. (hereinafter "CONTRACTOR"); From this point forward, the party referenced previously as "NMC" shall be referenced as "COUNTY" and collectively, COUNTY and CONTRACTOR are referred to as the "Parties" to this Agreement, with respect to the following:

### RECITALS

WHEREAS, the Agreement was executed for advertising recruitment services with a term of July 1, 2018 through June 30, 2020 and a total Agreement amount not to exceed \$400,000; and

WHEREAS, NMC and CONTRACTOR amended the Agreement on April 28, 2020 via Amendment No. 1 to extend the term for an additional one year period through June 30, 2021 and to add an additional \$200,000, thereby increasing the total Agreement amount to \$600,000; and

WHEREAS, NMC and CONTRACTOR currently wish to amended the Agreement on March 8, 2021 to extend it for an additional eighteen (18) months through December 31, 2022 to allow for services to continue with a \$300,000 increase for a total Agreement amount of \$900,000; and

WHEREAS, COUNTY and CONTRACTOR currently wish to amend the Agreement to extend it for an additional one (1) year period (January 1, 2023 through December 31, 2023) for a revised full agreement term of July 1, 2018 through December 31, 23 to allow for services to continue with a \$325,000 increase for the added services for a total Agreement amount of \$1,225,000 with no changes to the scope.

#### **AGREEMENT**

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the Original Agreement and in Amendment No 1, and Amendment No. 2, incorporated herein by this reference, except as specifically set forth below.

- Section 4.1, under "TERM OF AGREEMENT" shall be amended to the following:
   "The initial term shall commence on July 1, 2018 through and including December 31, 2023, with
   the option to extend the AGREEMENT two (2) additional one (1) year periods. NMC is not required
   to state a reason if it elects not to renew this AGREEMENT."
- 2. Section 5.2 under "COMPENSATION AND PAYMENTS shall be amended to the following: "Prices shall remain firm for the initial term of this AGREEMENT and, thereafter, may be adjusted annually as provided in this paragraph. NMC does not guarantee any minimum or maximum amount of dollars to be spent under this AGREEMENT. The total amount payable by NMC under this Agreement is not to exceed the sum of \$1,225,000."

- Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 3 and shall continue in full force and effect as set forth in the Agreement and Amendment No. 1, and Amendment No. 2.
- 4. A copy of this Amendment No. 3 shall be attached to the Agreement.
- 5. This Amendment No. 3 shall be effective when both parties have signed.
