WHEREAS, Monterey County, the cities of Salinas, Gonzales, Soledad, and King, the Monterey County Water Resources Agency, the Castroville Community Services District, and Monterey One Water (formerly the Monterey Regional Water Pollution Control Agency) formed the Salinas Valley Basin Groundwater Sustainability Agency ("SVBGSA"), a Joint Powers Authority ("JPA"); and,

**WHEREAS**, the SVBGSA is governed by an 11-member Board of Directors ("SVBGSA Board"), with Directors appointed by specific Members of the JPA; and,

WHEREAS, the County Board of Supervisors is the appointing authority for seven Director positions on the SVBGSA Board: 1) one "Other GSA Eligible Entity" position; 2) four "Agricultural" positions representing the Eastside Sub-basin area, the Forebay Sub-basin area, the 180/400 Sub-basin area, and the Upper Valley Sub-basin area; 3) one "Environment" position; and 4) one "Public Member" position; and,

WHEREAS, each Director position has a Primary and an Alternate Director; and,

**WHEREAS**, the permanent SVBGSA Board was established effective July 1, 2017, and three of the County's appointees, the Public Member, and the Eastside and Upper Valley Directors, were given initial two-year terms, expiring on June 30, 2019, and thereafter three-year terms to create staggered terms for the entire Board of Directors; and,

WHEREAS, the current terms of the Public Member Directors expired on June 30, 2022; and,

WHEREAS, the County has received nominations from the SVBGSA Board of Directors for the Public Member Director positions; and,

**WHEREAS**, the Board of Supervisors has considered the nominations of the individuals presented for consideration as appointees to the Public Member Director positions;

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Supervisors of the County of Monterey as follows:

- 1. The above recitals are true and correct.
- 2. Caroline Chapin is hereby appointed as the Primary Director to the Public Member Director position, and Robert Rodoni is appointed the Alternate Director, each for a term ending June 30, 2025.
