**WHEREAS, Paul Josselyn** began his career with the County of Monterey Agricultural Commissioner's office as a Agricultural Inspector/Biologist II in January 1992, and quickly promoted to the position of Agricultural Inspector/Biologist III in June 1993; and

**WHEREAS, Paul Josselyn** obtained special licenses during his tenure in Pesticide Regulation, Investigation & Environmental Monitoring, Integrated Pest Management, Commodity Regulation, Pest Prevention and Plant Regulation and Deputy Agricultural Commissioner, Weight Verification, Measurement Verification, Transaction and Product Verification, his Deputy Sealer of Weights and Measures license, and USDA Animal Plant Health Inspection Service Authorized Certification Officer; and

**WHEREAS, Paul Josselyn** has provided a valuable service to the citizens of Monterey County by inspecting and certifying various nurseries and incoming plant shipments to USDA and CDFA Quarantines to prevent the spread of evasive weeds, diseases and insects, certifying crop export shipments to meet foreign country Quarantine requirements and keep trade routes open; and

**WHEREAS, Paul Josselyn** has enforced Department of Pesticide Regulation laws to ensure public safety by approving and monitoring pest control practices applied to agricultural crops and sensitive zones, completed complex investigations into the cause of pesticide related complaints and responded to complaints of agricultural practices; and

**WHEREAS, Paul Josselyn** has ensured wholesome and quality produce to the public by enforcing CDFA's Fruit and Vegetable Standardization and Direct Marketing laws, inspecting Certified Farmers' crop production for quality and quantity for eligibility to sell at the California Certified Farmers' Markets; and

**WHEREAS, Paul Josselyn** has protected the citizens, environment and commerce of Monterey County through enforcement of federal, state and local law, resolving complaints of agricultural practices and complaints generated by the public, State agencies or competitor businesses; and

**NOW, THEREFORE, BE IT RESOLVED THAT,** the Monterey County Board of Supervisors commends and thanks **Paul Josselyn** for his 30 years of exemplary public service and his many contributions to the citizens of Monterey County, and he is wished much happiness as he begins his retirement.
