**APPROVING APPLICATION FOR LAND WATER CONSERVATION FUND
Salinas Regional Soccer Complex - Eight Playing Fields with Environmental Enhancements**

Adopt a Resolution to:

- a. Approve the filing of project application)
- for California Department of Parks and)
- Recreation Land Water Conservation Fund)

WHEREAS, Congress under Public Law 88-578 has authorized the establishment of a federal Land and Water Conservation Fund Grant-In-Aid program, providing matching funds to the State of California and its political subdivisions for acquiring lands and developing Facilities for public outdoor recreation purposes; and

WHEREAS, the California Department of Parks and Recreation is responsible for administration of the program in the State, setting up necessary rules and procedures governing APPLICATIONS by local agencies under the program; and

WHEREAS, the County of Monterey certifies by resolution the approval of the application and the availability of eligible matching funds prior to submission of the application to the State; and.

NOW, THEREFORE, BE IT RESOLVED THAT the Board of Supervisors of the County of Monterey hereby:

1. Approves the filing of an application for the Land and Water Conservation Fund assistance for the proposed Salinas Regional Soccer Complex- Eight Playing Fields with Environmental Enhancements; and
2. Certifies that the Applicant reviewed, understands and agrees to the General Provisions contained in the CONTRACT shown in the Grant Administration Guide; and
3. Agrees to abide by 54 U.S.C. Section 200305(f)(3) which requires, "No property acquired or developed with assistance under this section shall, without the approval of the National Secretary of the Interior, be converted to other than public outdoor recreation uses. The Secretary shall approve such conversion only if he finds it to be in accord with the then existing comprehensive statewide outdoor recreation plan and only upon such conditions as he deems necessary to assure the substitution of other recreation properties of at least equal fair market value and of reasonably equivalent usefulness and location."; and
4. Certifies that the Applicant has matching funds from eligible sources and can finance 100% of the Project, which up to half may be reimbursed; and

5. Agrees to comply with all applicable federal, state, and local laws, ordinances, rules, regulations, and guidelines; and
6. Appoints the County of Monterey Director of Public Works, Facilities and Parks as agent of the applicant to conduct all negotiations and execute and submit all documents, including but not limited to, applications, contracts, amendments, payment requests, and compliance with all applicable current state and federal laws which may be necessary for the completion of the aforementioned Project.
