AMENDMENT #1 TO AGREEMENT # A-14944 BY AND BETWEEN COUNTY OF MONTEREY & GEO REENTRY SERVICES, LLC

THIS AMENDMENT is made to the Agreement for the provision of services to adult offenders participating in the Day Reporting Center by and between **GEO REENTRY SERVICES, LLC,** hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County" (collectively, "the Parties").

WHEREAS, the County and CONTRACTOR first entered into the Agreement on September 1, 2020 by board action for the term September 1, 2020 through August 31, 2023, not to exceed \$1,004,663 annually, for a total of \$3,013,989; and

WHEREAS, effective January 1, 2021, the CONTRACTOR will be relocating to a new business address for Day Reporting Center services; and

WHEREAS, the County and CONTRACTOR wish to amend the Agreement to update Exhibit A with the new business location, to allow CONTRACTOR to continue to provide services identified in the Agreement.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the Agreement, effective January 1, 2021, as follows:

- 1. Exhibit A, Section "A.2 Minimum Requirements", Paragraph "Location", shall be amended by removing "CONTRACTOR's site for the DRC is located at 427 Pajaro Street, Salinas, CA 93901, and replacing it with "CONTRACTOR's site for the DRC is located at 126 Sun Street, Salinas, CA 93901."
- 2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the Agreement.
- 3. This Amendment No. 1 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.
- 4. The recitals to this Amendment No. 1 are incorporated into the Agreement and this Amendment No.1.
