RECITALS:

WHEREAS, the County and Contractor have heretofore entered into a Professional Services Agreement ("Agreement") with a term of July 1, 2009 to June 30, 2010;

WHEREAS, the County desires to retain Contractor to provide credentialing and re-credentialing of health care provider and facility applications; and

WHEREAS, the parties desire to amend the Agreement as specified below.

NOW THEREFORE, in consideration of the mutual agreements and covenants contained therein and for other good and valuable consideration, the receipt and sufficiency of which hereby are acknowledged, it is mutually agreed and covenanted by and between the parties to the Agreement and this Amendment No. 1, as follows:

- 1. Section 2, <u>Payments by County</u>, is amended to increase the total amount payable by County to Contractor by Fifty-Four Thousand Dollars (\$54,000.00) for a combined amount not to exceed the sum of Seventy-Eight Thousand Dollars (\$78,000.00) for the term of this Agreement.
- 2. Section 3, <u>Term of Agreement</u>, is amended to extend term from July 1, 2010 to June 30, 2012.
- 3. EXHIBIT A is replaced with Amendment No. 1 to EXHIBIT A. All references in the Agreement to EXHIBIT A shall be construed to refer to Amendment No. 1 to EXHIBIT A.
- 4. Except as provided herein, all remaining terms and conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the Agreement.
- 5. A Copy of this Amendment No. 1 shall be attached to the Agreement.
