## AMENDMENT NO. 2

## To

## Agreement for Professional Services By and between County of Monterey and TR & Associates, Inc.

This Amendment No. 2 is made and entered into, by and between the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County", and TR & Associates, Inc., hereinafter referred to as "CONTRACTOR".

## RECITALS:

WHEREAS, the County and CONTRACTOR have heretofore entered into a Professional Services Agreement ("Agreement") with a term of July 1, 2009 to June 30, 2010;

WHEREAS, on or about June 9, 2010, the County and CONTRACTOR entered into an executed Amendment No. 1 to extend the term of the Agreement for two (2) additional years for a new Agreement amount not to exceed \$78,000.00 for the period of July 1, 2009 to June 30, 2012; and

WHEREAS, the County and CONTRACTOR wish to amend the Agreement to extend the term of Agreement for two (2) additional years, as specified below.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the Agreement, as follows:

- 1. Section 2, <u>Payments by County</u>, as previously amended, is amended to increase the total amount payable by County to CONTRACTOR by \$60,000.00 for a combined amount not to exceed \$138,000.00 for the term of this Agreement.
- 2. Section 3, <u>Term of Agreement</u>, as previously amended, is amended to extend the term of the Agreement to June 30, 2014 for a new term of July 1, 2009 to June 30, 2014.
- 3. AMENDMENT NO. 1 to EXHIBIT A is replaced with AMENDMENT NO. 2 to EXHIBIT A. All references in the Agreement to AMENDMENT NO. 1 to EXHIBIT A shall be construed to refer to AMENDMENT NO. 2 to EXHIBIT A.
- 4. Except as provided herein, all remaining terms and conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the Agreement.
- 5. A Copy of this Amendment No. 2 shall be attached to the Agreement.
- 6. The effective date of this Amendment No. 2 is July 1, 2012.
