AMENDMENT No. 2 FOR PROFESSIONAL SERVICES AGREEMENT BETWEEN Maintenance Connection, Inc. AND THE NATIVIDAD MEDICAL CENTER FOR

<u>Database Software Maintenance, Systems Configuration, End-user Training, Main-user Training and Monthly Service Fees</u>

The parties to Professional Services Agreement ("Agreement"), dated July 1, 2010 between the County of Monterey, on behalf of Natividad Medical Center ("NMC"), and Maintenance Connection, Inc. (Contractor), hereby agree to amend their Agreement (No.SC 1927) on the following terms and conditions:

WHEREAS, the County and Contractor wish to amend the Agreement to extend the term end date to allow for existing services to continue.

WHEREAS, the County and Contractor wish to amend the Agreement to increase the amount of the Agreement because of the term extension.

WHEREAS, the County and Contractor amended the Agreement previously on July 1, 2011via Amendment No.

- 1. Contractor will continue to provide NMC with the same scope of services as stated in the original Agreement (No.SC 1927).
- 2. Section 1, "PAYMENTS BY NMC" shall be amended by removing, "The total amount payable by NMC to CONTRACTOR under this Agreement shall not exceed the sum of \$43,560.00." and replacing it with "The total amount payable by County to CONTRACTOR under Agreement No. (SC 1927) shall not exceed the total sum of \$75,561.00 for the full term of the Agreement."
- 3. Section 2, "TERM OF AGREEMENT" shall be amended by removing, "The term of this Agreement is from June 1, 2010 to June 30, 2012 unless sooner terminated pursuant to this Agreement" and replacing it with "The term of this Agreement is from June 1, 2010 to June 30, 2013 unless sooner terminated pursuant to this Agreement."
- 4. All other terms and conditions of the Agreement shall continue in full force and effect. Except as provided herein, all remaining terms, conditions, and provisions of the Agreement and Amendment Nos. 1 is unchanged and unaffected by this Amendment and shall continue in full force and effect as set forth in the Agreement.
- 5. A copy of this Amendment and all previous amendments shall be attached to the original Agreement (No.SC 1927).
- 6. The effective date of this Amendment is July 1, 2012.
