WHEREAS, only twenty-seven percent of U.S. adults get enough fruit and vegetables, and more than thirty-three percent of U.S. children eat less than one serving of fresh produce a day; and

WHEREAS, Americans are nearly twice as likely to be obese as the rest of the world's population; and

WHEREAS, Dole Food Company, as one the world's largest providers of fresh fruits and vegetables, and a recognized leader in nutritional research and education, is committed to helping reverse these trends; and
