AMENDMENT No. 8 to the MPTS MAINTENANCE AGREEMENT (A-07625) between MEGABYTE SYSTEMS, INC. and the County of Monterey

THIS AMENDMENT No. 8, is made to the Contractual Agreement A-70625 (hereinafter referred to as "A-07625") dated April 28, 1998, and its Addendum, the Software Upgrade MPTS2000+ dated July 1, 2007, as it had been subject to Amendment Nos. 1, 2, 3, 4, 5, 6, and 7, combined referred to herein as "Agreement", between Megabyte Systems, Inc., hereinafter referred to as "Contractor", and the County of Monterey, hereinafter referred to as "County".

WHEREAS, COUNTY and CONTRACTOR wishes to amend the Agreement to include an additional year of maintenance for the Megabyte Property Tax System for fiscal year 2015-2016 at a 0.8% cost of living increase from the current annual rate.

NOW THEREFORE, COUNTY and CONTRACTOR agree to amend the Agreement as follows:

- 1. The term of the maintenance and support services as identified in the attached Exhibit 2015/16A shall be extended for an additional year through and including June 30, 2016. For the maintenance and support between July 1, 2015 and June 30, 2016, the payment rates for services performed by Contractor for the additional time period shall be amended as set forth in the attached Exhibit 2015/16A to this Amendment No. 8. The total financial liability to the County for July 1, 2015 to June 30, 2016 pursuant to the terms of this Agreement shall not exceed \$332,716.14.
- 2. Except as provided herein, all remaining terms, conditions, provisions, entitlements and obligations of the original Agreement, as it has been subject to Addendum and Amendment to date, shall remain unchanged and unaffected by this Amendment and shall continue in full force and effect. A copy of this Addendum No. 8 and its Exhibit 2015/16A shall be affixed to the original Agreement as it may have been amended to date.
