AMENDMENT NO. 2 TO PROFESSIONAL SERVICES AGREEMENT BETWEEN GNU Group AND THE NATIVIDAD MEDICAL CENTER FOR

Signage Analysis & Master Plan Services at NMC

This Amendment No. 2 to Professional Services Agreement ("Agreement"), dated September 1, 2013, is entered into by and between the County of Monterey, on behalf of Natividad Medical Center ("NMC"), and **GNU Group** (Contractor), with respect to the following:

RECITALS

WHEREAS, the Agreement was executed for Signage Analysis & Master Plan Services per RFQ 9600-42 with a Nine (9) month term September 1, 2013 through June 30, 2014 and with a total amount not to exceed \$184, 500, NMC approve two (2) future amendments to extend the term of the Agreement for two (2) additional one (1) year periods and to increase the Agreement by no more than 5% of the original Agreement amount per each subsequent fiscal year; and

WHEREAS, NMC and CONTRACTOR amended the Agreement via Amendment No.1 wish to amend the Agreement to extend the term for an additional one (1) year period through June 30, 2015 with no increase to the total agreement amount; and

WHEREAS, NMC and CONTRACTOR currently wish to amend the Agreement to extend the term for an additional one year period through June 30, 2016 to allow for services to continue and to also add additional services to the scope of work attached hereto as" Exhibit –A-2 per Amendment No.2" with a \$78,860 increase for the added services for the total Agreement amount of \$263,360.

AGREEMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

- 1. The Agreement is hereby renewed on the terms and conditions as set forth in Original Agreement and in Amendment No.1 and 2, incorporated herein by this reference, except as specifically set forth below.
- Section 4, "Scope of Services" shall be amended to include all of the following: Phase 1 Interior Signage, Phase 2 exterior Signage and Exhibit-A-2 per Amendment No.2.
- 3. Section 5. "TERM OF AGREEMENT" shall be amended to the following; "The term of the AGREEMENT is September 1, 2013 through and including June 30, 2016".
- 4. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment and shall continue in full force and effect as set forth in the Agreement.
- 5. A copy of this Amendment No. 2 shall be attached to the original Agreement (No.12552/MYA1021).

I. Project Understanding

GNU Group will provide construction administration for the exterior and interior Wayfinding Master Program (WMP) for final and approved design and programming documentation.

 - Develop exterior Master Sign Program documentation and planning approvals
 - Development of bid narrative and written performance specifications in conjunction with Natividad Medical Center (NMC) for fabrication and installation services
 - Meeting with selected fabricator/installer
 - Information coordination with architect for OSHPD submittal
 - Fabricator construction/shop drawing/proof, samples and color reviews
 - Project meetings, schedule development, coordination and maintenance
 - Coordination with facilities/engineering or GC of architectural modifications to include: painting, minor wall renovations and installation of structural backing

IV. Reimbursable Expenses

"Natividad Medical Center (County of Monterey) and CONTRACTOR agree that CONTRACTOR shall be reimbursed for travel expenses during this Agreement. If not, then at the option of NMC, this Agreement shall be retroactively modified and adjusted to include and apply the more favorable prices, terms, conditions, and benefits.
